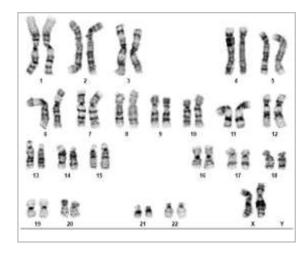

Limitations: This assay allows for microscopic visualization of numerical and structural chromosome abnormalities. The size of structural abnormality that can be detected is >3-10Mb, dependent upon the G-band resolution obtained from this specimen. For the purposes of this report, band level is defined as the number of G-bands per haploid genome. It is documented here as "band level", i.e., the range of bands determined from the four karyograms in this assay. Detection of heterogeneity of clonal cell populations in this specimen (i.e.,mosaicism) is limited by the number of metaphase cells examined, documented here as "# of cells counted".

## **Short Tandem Repeat**

<u>Assay Description:</u> Short Tandem Repeat (STR) analysis is performed using the PowerPlex® 16 HS System by Promega<sup>™</sup>. Results are reported as 13 CODIS STR markers, Amelogenin for sex determination and two low-stutter, highly discriminating pentanucleotide STR markers.

<u>Results:</u> The genotypic profiles comprise a range of 28 allelic polymorphisms across the 15 STR loci analyzed. Sample 108862 is a 100% match to to 108816, 108815, 108777, 108755, 108624, 108613, 108572, 108571, 108531, 108532, and additional profiles. Additional matches can be provided upon request.

<u>Interpretation:</u> The concentration of DNA required to achieve an acceptable STR genotype (signal/ noise) was equivalent to that required for the standard procedure (~1 ng/amplification reaction) from human genomic DNA. These results suggest that the cells submitted correspond to the cell lines as named and were not contaminated with any other human cells or a significant amount of mouse feeder layer cells.

Sensitivity: Sensitivity limits for detection of STR polymorphisms unique to either this or other human cell lines is ~2-4%.
