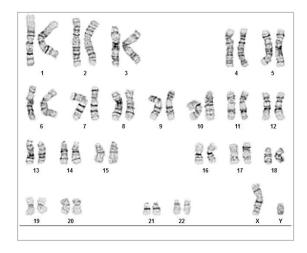

Results: Based on the 13061-STR cells submitted by WiCell QA dated and received on 11/20/17, this sample (Label on Tube: 13061-STR) defines the STR profile of the human stem cell line UCSD193i-106-1 comprising 26 allelic polymorphisms across the 15 STR loci analyzed.

Interpretation: No STR polymorphisms other than those corresponding to the human UCSD193i-106-1 stem cell line were detected and the concentration of DNA required to achieve an acceptable STR genotype (signal/ noise) was equivalent to that required for the standard procedure (~1 ng/amplification reaction) from human genomic DNA. This result suggests that the 13061-STR sample submitted corresponds to the UCSD193i-106-1 stem cell line and was not contaminated with any other human stem cells or a significant amount of mouse feeder layer cells.

Sensitivity: Sensitivity limits for detection of STR polymorphisms unique to either this or other human stem cell lines is $\sim 2-5\%$.
