

This is an abnormal karyotype. Twenty of twenty cells examined contain an apparently balanced rearrangement of chromosome 13. This chromosomal aberration is not considered recurrently acquired in cultures of this cell type. No other clonal abnormalities were detected at the stated band level of resolution.

<u>Results:</u> Based on the 13712-STR cells submitted by WiCell QA dated and received on 06/18/18, this sample (Label on Tube: 13712-STR) defines the STR profile of the human stem cell line UCSD214i-14-2 comprising 30 allelic polymorphisms across the 15 STR loci analyzed.

<u>Interpretation:</u> No STR polymorphisms other than those corresponding to the human UCSD214i-14-2 stem cell line were detected and the concentration of DNA required to achieve an acceptable STR genotype (signal/noise) was equivalent to that required for the standard procedure (~1 ng/amplification reaction) from human genomic DNA. This result suggests that the 13712-STR sample submitted corresponds to the UCSD214i-14-2 stem cell line and was not contaminated with any other human stem cells or a significant amount of mouse feeder layer cells.

<u>Sensitivity:</u> Sensitivity limits for detection of STR polymorphisms unique to either this or other human stem cell lines is ~2-5%.
