

Interpretation:

This is an abnormal karyotype. An extra copy of chromosome 12 is present in five of twenty cells examined. Gain of chromosome 12 is recurrently acquired in cultures of this cell type. No other clonal abnormalities were detected at the stated band level of resolution.

Limitations: This assay allows for microscopic visualization of numerical and structural chromosome abnormalities. The size of structural abnormality that can be detected is >3-10Mb, dependent upon the G-band resolution obtained from this specimen. For the purposes of this report, band level is defined as the number of G-bands per haploid genome. It is documented here as "band level", i.e., the range of bands determined from the four karyograms in this assay. Detection of heterogeneity of clonal cell populations in this specimen (i.e.,mosaicism) is limited by the number of metaphase cells examined, documented here as "# of cells counted".

<u>Results:</u> Based on the 13833-STR cells submitted by WiCell QA dated and received on 07/16/18, this sample (Label on Tube: 13833-STR) defines the STR profile of the human stem cell line UCSD211i-32-1 comprising 26 allelic polymorphisms across the 15 STR loci analyzed.

<u>Interpretation:</u> No STR polymorphisms other than those corresponding to the human UCSD211i-32-1 stem cell line were detected and the concentration of DNA required to achieve an acceptable STR genotype (signal/noise) was equivalent to that required for the standard procedure (~1 ng/amplification reaction) from human genomic DNA. This result suggests that the 13833-STR sample submitted corresponds to the UCSD211i-32-1 stem cell line and was not contaminated with any other human stem cells or a significant amount of mouse feeder layer cells.

<u>Sensitivity:</u> Sensitivity limits for detection of STR polymorphisms unique to either this or other human stem cell lines is ~2-5%.
