

#### Interpretation:

This is an abnormal karyotype. An additional copy of chromosome 8 is present in two of twenty cells examined. Gain of chromosome 8 is recurrently acquired in pluripotent stem cell cultures.

No other clonal abnormalities were detected at the stated band level of resolution.

Limitations: This assay allows for microscopic visualization of numerical and structural chromosome abnormalities. The size of structural abnormality that can be detected is >3-10Mb, dependent upon the G-band resolution obtained from this specimen. For the purposes of this report, band level is defined as the number of G-bands per haploid genome. It is documented here as "band level", i.e., the range of bands determined from the four karyograms in this assay. Detection of heterogeneity of clonal

cell populations in this specimen (i.e., mosaicism) is limited by the number of metaphase cells examined, documented here as "# of cells counted".

<u>Results:</u> Based on the MCW013i-A2767-WB67191 15253 p.15 (80010) D01 DNA submitted by WiCell Characterization Department dated and received on 02/03/20, this sample (Label on Tube: MCW013i-A2767-WB67191 15253 p.15 (80010) D01) defines the STR profile of the human cell line MCW013i-A2767 comprising 26 allelic polymorphisms across the 15 STR loci analyzed.

<u>Interpretation</u>: No STR polymorphisms other than those corresponding to the human MCW013i-A2767 cell line were detected and the concentration of DNA required to achieve an acceptable STR genotype (signal/ noise) was equivalent to that required for the standard procedure (~1 ng/amplification reaction) from human genomic DNA. This result suggests that the MCW013i-A2767 sample submitted corresponds to the MCW013i-A2767-WB67191 15253 p.15 (80010) D01 cell line and was not contaminated with any other human stem cells or a significant amount of mouse feeder layer cells.

Sensitivity: Sensitivity limits for detection of STR polymorphisms unique to either this or other human cell lines is ~2-5%.
